We only ask for personal information when we truly need it to provide a service to you. We collect it by fair and lawful means, with your knowledge and consent. Personal data is processed only on the basis of currently applicable legal foundations. We only retain collected information for as long as necessary to provide you with your requested service.

Your personal data is processed within the scope described below for the purposes explained. The purposes of the processing of personal data lie in conducting the business of Vlahovic Group LLC.

- **Contact form and email contact:** On our website there is a contact form to contact us electronically. If you choose this option, the data entered into the entry form will be transferred to us and stored.
- **Newsletter:** We send a biweekly political update newsletter „News from Zagreb's St. Mark's Square“. It is possible to subscribe to our newsletter via our website as well as to opt-out/unsubscribe anytime by sending a request via email to info@vlahovicgroup.com or simply to choose „unsubscribe from the list“ at the footer section of the newsletter. For this purpose, the data required for sending the newsletter is stored.
- **Processing of business contacts:** For business reasons, we receive or collect contact information on various occasions from employees and managing directors of other companies, as well as from public officials or holders of public office. This information, which is usually provided personally or is publicly available, is stored in our contact database as a business contact.
- **When you make a job application** at careers@vlahovicgroup.com: We solely process the personal data that you send us in the course of an application for the purpose of processing the application.

IP Anonymization: We do not use cookies to uniquely identify a device or the person using that device which is considered personal data under the GDPR. Thus, we do not require your cookie consent. However, we use Google Analytics to better understand users' behavior on the website and interests for certain content. We prevented the collection of personal data from our website's Google Analytics tracking code, anonymizing the website users' IP addresses.

Legal basis for the processing of personal data:

- Article 6 (1)(b) GDPR is the legal basis for processing personal data that is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.
- Article 6 (1)(f) GDPR forms the legal basis for the processing if the processing is necessary for the purposes of the legitimate interests pursued by Vlahovic Group or a third party and such interests are not overridden by the interests or fundamental rights and freedoms of the data subject.
- Article 6 (1)(a) GDPR forms the legal basis when we obtain consent for processing operations for personal data from the data subject.
- Article 6 (1)(c) GDPR forms the legal basis when the processing of personal data is necessary for compliance with a legal obligation to which our company is subject.
- Article 6 (1)(d) GDPR forms the legal basis in the event that the processing of personal data is necessary in order to protect the vital interests of the data subject or of another natural person.

We reserve the right to modify this privacy policy as new services are provided or changed in order to be in compliance with current legal requirements. The actual version will then be applicable for your renewed visit to our website.
